**House Plants:** 1 tablespoon of product per gallon of water every 2-3 weeks.

**Root Dip:** Dip roots of all transplants before planting. Use straight Vermaplex.

**Turf:** Apply 3 ounces of product per 1 gallon of water per 125 square feet. Spray volume of 67 gallons per acre, applying monthly during growing season and again in late fall.

**Transplanting/Cutting:** Apply 1/2 gallon of product per 20 gallons of water at time of transplanting or cutting **Deep**

**Root Fertilization:** Apply 50 gallons of product per 100 gallons of water. Injection sites should be 2 to 3 feet apart, and 12-15 inches deep for established trees on a radial grid pattern
